Its Rising Stars program was founded in 1998 and recognizes the top up-and-coming attorneys who are 40 years old or younger, or who have been practicing for 10 years or less.

Bailey is one of the top health care attorneys in Nevada. He is a two-time past chairman and member of the Nevada State Athletic Commission. He has served as vice chairman and a member of the Moral Character and Fitness Committee of the Nevada State Bar for 15 years and is a former General Counsel for the State Republican Party. He has been recommended to the President of the United States for a Judgeship on the U.S. Court of Appeals for the Ninth Circuit by Senators John Ensign and Harry Reid.

Kennedy has been practicing law in Nevada for 34 years and is known as one of the state’s top litigators. He has represented many of the country’s leading drug, food, health care, insurance, tobacco, hotel-casino, and other companies in both the enforcement and defense of their rights. He is a former adjunct professor of law at UNLV’s Boyd School of Law and currently the co-editor of the *Nevada Civil Practice Manual* -- the definitive authority on Nevada civil practice and procedure.

Kennedy received another of the legal profession’s highest individual honors this year when he was given a “1” ranking in the Chambers USA 2009 listing of outstanding attorneys. Kennedy has been listed with a “1” ranking in the Chambers USA category of Litigation: General/Commercial in Nevada since 2003.

Dickey’s legal practice focuses on complex civil litigation, including disputes in such areas as commercial law, corporate law, business torts, and constitutional law. He is a member of the State Bar of Nevada, Southern Nevada Disciplinary Board and is on the editorial staff of the Nevada Civil Practice Manual.

Eaton’s practice includes sports & entertainment law, privileged licensing, and transactional work. He is a contributing author to Nevada Gaming Law and was named one of Las Vegas’ “Top Businesspeople Under 40” by *In Business Las Vegas*.
